

# BOSTON BIG LOCAL COMMUNITY EVENTS GRANTS SCHEME 3.1.1 and 3.1.2

Activity and financial report Y4 Q2 July – September 2018

### Administration and Scheme Overview

- The scheme continues to be promoted on the LCVS and BBL websites and to groups face to face where appropriate.
- Invoice for £2020 is currently being raised by Boston United Community Foundation for their 2<sup>nd</sup> event, which is now due to take place on Sat 30<sup>th</sup> March 2019.
- We are currently awaiting an Events Report from Butterfly Hospice Trust for their 2018 mini
  Marathon Event. Once received and approved by the panel, an invoice for £312 will be raised
  for their 2019 mini marathon.

#### Round 5:

- In Round 5 an application for £3000 was received from The Parish of Boston to support their A Festival of Remembrance Event. The events panel approved this application for funding meaning that the events grant has now been fully allocated.
- We also received an events application after from We'll Meet Again Museum for £1200 for a Big Band Night at the Blackfriars Theatre after the deadline and the panel meeting, which we forwarded onto the main residents' panel to consider.

#### **Finance**

Current allocated spend as of 30th September 2018 is as follows:

Theme 3.1.1 = £4500 broken down as follows:

- £4485 for 2 x Boston United Events
- £15 for Butterfly Hospice's 2019 Mini Marathon Event

Theme 3.1.2 = £4500 broken down as follows:

- £887 for Carers First Event
- £316 for Butterfly Hospice 2018 Mini Marathon
- £297 for Butterfly Hospice's 2019 Mini Marathon Event
- £3000 for The Parish of Boston's Festival of Remembrance Event

This means that all the events grant has been allocated for 2018/2019.

## **Underspends**

Following the event reports, the following underspends were noted and reassigned by the panel:

Carers First: Underspend of £124.26 to be used to support events in the BBL area for Carers Rights Day (30th Nov 2018) and Young Carers Day (31st Jan 2019).

Boston United Community Foundation: Underspend of £370 due to poor weather on the day to be carried over to the next Fun Day Event on 30<sup>th</sup> March 2019.
